Executive Summary

Community Action stepped up in 2023 to make an impact in our community. Following the previous year's needs assessment, the Agency strategically planned to reach underserved areas, utilize public input, and strengthen relationships with community stakeholders. Key events during the year included four resource fair events, facilitated by Community Action that included over 20 partnering agencies. All three counties we serve each hosted one of these events with the fourth one being centrally located.

Acknowledging the housing and food insecurity in our area, our Agency made a difference by taking on a co-lead position on MSHDA's statewide housing plan as well as hosting public input sessions in our buildings for MSDHA's Executive Director, the Office of Community Services, and the Bureau of Aging, Community Living, and Supports to advocate for our specific community's needs. We also took the advocating to our legislators by visiting the State's capitol and meeting with our Senators and House members, as well as meet with our federal senator Debbie Stabenow.

Fundraising efforts continued through a successful Walk for Warmth that reintroduced external stakeholder planning and participation.

A record-breaking homeless fundraiser during Homeless Awareness Month helped raise dollars for our homeless population to receive shelter nights and transportation to security. Multiple, innovative partnerships locally helped raise new contributions and encourage community stakeholders, through these new partnerships, to support the programs that aide our own neighbors that are less fortunate.
